Criminal Injuries Compensation

If you have been injured as a result of a **crime committed against you**, you may be entitled to claim for damages under the Criminal Injuries Compensation Act.

The Criminal Injuries Compensation scheme is, in effect, a scheme which is underwritten by the State of South Australia to ensure that victims of crime receive some compensation.

Many people do not pursue criminal injuries compensation because they believe the matter or the injury to be minor. In some cases they are simply unaware of their right to pursue such compensation. Please don't be one to miss out if there is a chance of making a claim.

Product liability

People are not often aware that if they have suffered personal injury and/or property loss or damage as a result of **faulty products or contaminated food** they may be entitled to compensation.

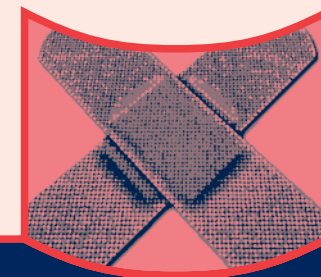

If you are injured at work, on the road or in a public place you may be entitled to compensation.

This is not to say that if you are injured in an accident, you are automatically entitled to compensation. Insurance restrictions have made claims harder to make in recent times.

Motor Vehicle Accidents

These types of claims can cover any form of motor driven transport including car, bus, and so on.

We will tell you whether we do or do not think that you have a claim.

Many people are not aware that if they are injured in a motor vehicle accident they may be entitled to compensation.

The claim is made on the third party insurance company of the driver who caused the accident.

If you were a passenger you may have a claim against either the driver of the car in which you were travelling or the driver of the other car.

On occasions where the accident was caused by negligence on the part of each driver, you may still have a claim for compensation.

Please be aware that time limits apply in relation to your ability to make a claim for compensation. We recommend that you talk to us about your claim.

Medical Negligence

It has recently been reported that medical negligence **kills more than 18,000** and permanently **disables 50,000 Australians** every year, costing taxpayers approximately **\$4.17 billion annually**.

If you have had treatment or received advice from **a doctor or other health professional:**

- Where you were not advised about the risks associated with the treatment you received or the advice you were given; or
- Where the results of treatment have not been what you were told to expect; or
- Where the doctor or health care provider makes a wrong judgment in their treatment of you causing further injury

then you may have a claim for compensation.

Workers Compensation

If you are injured at work, you may be entitled to **Workers Compensation** whether or not your employer or someone else is at fault for your injury.

The Workers Compensation and Rehabilitation Act is a compensation scheme which deals with compensation for injuries at work, including:

- Income Maintenance
- Medical Expenses
- Lump Sum Compensation for non-economic loss (Section 43)
- Redemption Agreements

Public Liability

Have you been injured because of somebody else's negligence at home, in a public place or on a sporting field? If so, you may be entitled to compensation.

Many people are not aware that if they have been injured in a public place or private residence they may be entitled to claim compensation for their injuries.
